It is anticipated that the following item may be considered by the Committee:

PROPOSAL NO. 141, 2025 - appoints Victoria Beaty to the Indianapolis City Market Corporation Board of Directors

PROPOSAL NO. 142, 2025 - reappoints Barney Levengood to the Indianapolis City Market Corporation Board of Directors

PROPOSAL NO. 143, 2025 - reappoints Craig Mince to the Indianapolis City Market Corporation Board of Directors

PROPOSAL NO. 145, 2025 - approves the statement of benefits of Kimball Electronics Indianapolis, Inc., an applicant for tax abatement for property located in an economic revitalization area

PROPOSAL NO. 146, 2025 - approves payments in lieu of taxes (PILOTs) for Grand Meridian, LP, for an affordable 94-unit housing project, financed in part with low-income housing tax credits, to be located at 3470 North Meridian Street in district 8, in accordance with IC 36-3-2-12

PROPOSAL NO. 167, 2025 - approves a transfer of \$10,000 in the 2025 Budget of the Marion County Recorder's Office (County Records Perpetuation Fund) for the replacement of printing equipment

PROPOSAL NO. 168, 2025 - approves an additional appropriation totaling \$1,914,025 in the 2025 Budget of the Department of Metropolitan Development in various funds for the purposes of funding the costs associated with property taxes, capital repairs of DMD owned properties, Central State Section 108 debt, remediation at 3515 E. Washington, and infrastructure development within the Lafayette Road area
