CITY-COUNTY GENERAL ORDINANCE NO. , 2025

PROPOSAL FOR A GENERAL ORDINANCE to amend the Revised Code to make various changes to Chapter 621, Parking, standing and stopping restricted.

BE IT ORDAINED BY THE CITY-COUNTY COUNCIL OF THE
CITY OF INDIANAPOLIS AND OF MARION COUNTY, INDIANA:

SECTION 1. That the Revised Code of the Consolidated City and County, Indianapolis/Marion County, Indiana, specifically Sec. 621-121 (b), Parking prohibited at all times on certain streets, be, and the same is hereby amended by the deletion of the following, to wit:

DELETE: Sec. 621-121. - Parking prohibited at all times on certain streets.

(b) The streets or portions of streets to which the prohibition contained in subsection (a) shall apply are as follows:

Sixteenth Street, on the north side, from Central Avenue to Roosevelt Avenue;

East Sixteenth Street, on the south side, from Alvord Street to Yandes Street;

SECTION 2. That the Revised Code of the Consolidated City and County, Indianapolis/Marion County, Indiana, specifically Sec. 621-121 (b), Parking prohibited at all times on certain streets, be, and the same is hereby amended by the addition of the following, to wit:

ADD: Sec. 621-121. - Parking prohibited at all times on certain streets.

(b) The streets or portions of streets to which the prohibition contained in subsection (a) shall apply are as follows:

Sixteenth Street, on the north side, from the Monon Trail Crossing to a point 90 feet east of the Monon Trail Crossing;

Sixteenth Street, on the south side, from a point 60 feet west of the Monon Trail Crossing to the Monon Trail Crossing;

Sixteenth Street, on the south side, from Sheldon Street to Roosevelt Avenue;

SECTION 3. That the Revised Code of the Consolidated City and County, Indianapolis/Marion County, Indiana, specifically Sec. 621-125, Stopping, standing and parking prohibited at designated locations on certain days and hours, be, and the same is hereby amended by the deletion of the following, to wit:

DELETE: Sec. 621-125. – Stopping, standing and parking prohibited at designated locations on certain days and hours.

SUNDAYS AND HOLIDAYS**
From 7:00 a.m. to 9:00 a.m.

Sixteenth Street, on both sides, from Central Avenue to Roosevelt Avenue;

From 4:00 p.m. to 6:00 p.m.

Sixteenth Street, on both sides, from Central Avenue and Roosevelt Avenue;

SECTION 4. That the Revised Code of the Consolidated City and County, Indianapolis/Marion County, Indiana, specifically Sec. 621-125, Stopping, standing and parking prohibited at designated locations on certain days and hours, be, and the same is hereby amended by the addition of the following, to wit:

ADD: Sec. 621-125. – Stopping, standing and parking prohibited at designated locations on certain days and hours.

**ON ANY DAY EXCEPT SATURDAYS,
SUNDAYS AND HOLIDAYS**
From 7:00 a.m. to 9:00 a.m.

Sixteenth Street, on the both sides, from Central Avenue to College Avenue;

**ON ANY DAY EXCEPT SATURDAYS,
SUNDAYS AND HOLIDAYS**
From 4:00 p.m. to 6:00 p.m.

Sixteenth Street, on both sides, from Central Avenue and College Avenue;

SECTION 5. The expressed or implied repeal or amendment by this ordinance of any other ordinance or part of any other ordinance does not affect any rights or liabilities accrued, penalties incurred, or proceedings begun prior to the effective date of this ordinance. Those rights, liabilities, and proceedings are continued, and penalties shall be imposed and enforced under the repealed or amended ordinance as if this ordinance had not been adopted.

SECTION 6. Should any provision (section, paragraph, sentence, clause, or any other portion) of this ordinance be declared by a court of competent jurisdiction to be invalid for any reason, the remaining provision or provisions shall not be affected, if and only if such remaining provisions can, without the invalid provision or provisions, be given the effect intended by the Council in adopting this ordinance. To this end the provisions of this ordinance are severable.

SECTION 7. This ordinance shall be in effect from and after its passage by the Council and compliance with Ind. Code § 36-3-4-14.
