ADOPTION OF THE AGENDA

PRESENTATION OF PETITIONS, MEMORIALS, SPECIAL RESOLUTIONS, AND COUNCIL RESOLUTIONS

PROPOSAL NO. 157, 2025. The proposal, sponsored by Councilor Mowery, recognizes the Indy Air Bears' qualification to compete on Team USA in the International Jump Rope Union World Championship in Kawasaki, Kanagawa, Japan. WHEREAS, the Indy Air Bears jump rope team was founded in 1986 by Niki Glover. Glover began the team with 14 Arlington Elementary students in grades 2-5 as an after-school club for fitness. It was first known as the Arlington Air Bears, but when jumpers remained on the team through middle and high school, the name was changed to the Indy Air Bears; and

WHEREAS, within a year of its inception, the team tripled in size and was being invited to perform at venues all around the Indianapolis area. The Air Bears continue to be based at Arlington Elementary and are annually comprised of 35-40 boys and girls from grade 3 to college and beyond. The team has served as ambassadors for the American Heart Association in the 'Jump Rope for Heart' program since 1987; and

WHEREAS, although originally meant to be a performance team, the Air Bears have found great success over the years both in National and International competitions. The Air Bears have hosted their own Indy Open tournament annually since 2000, and have performed in over 230 schools nationwide; and

WHEREAS, in addition, they have performed numerous halftime shows at all levels, including annual shows at Ball State, Purdue, Indiana, Butler, and IUPUI, as well as for Indiana Pacers, Indiana Fever, and Indianapolis Colts. They also entertained for two Women's Final Four tournaments, in Indianapolis and in Nashville, TN. The team has performed in the 500 Festival Parade, and several jumpers have performed in four different Macy's Thanksgiving Day Parades, as well as in the Rose Bowl Parade; and

WHEREAS, Sonora O'Connor of Shelbyville High School, Bria Mittendorf of Franklin Central High School, Brendan Fisher, Ella Fisher and Owen Willing of Franklin Central High School, Ella Beck of Franklin College, Blake Long, Franklin Central High School graduate and Elise McQueen Franklin Central High School/Ball State graduate, are members of the current Indy Air Bears jump rope team, who qualified to compete on Team USA in the International Jump Rope Union World Championship, which will be held in Kawasaki, Kanagawa, Japan, in July of 2025; now, therefore:

CITY-COUNTY GENERAL ORDINANCE NO. 14, 2025

PROPOSAL FOR A GENERAL ORDINANCE to establish petty cash funds to be placed in the custody of the Marion County Treasurer's Office to pay small or emergency items of operating expense, as authorized by Ind. Code § 36-1-8-3.

BE IT ORDAINED BY THE CITY-COUNTY COUNCIL OF THE CITY OF INDIANAPOLIS AND OF MARION COUNTY, INDIANA:

SECTION 1. Chapter 135, Article VIII, of the "Revised Code of the Consolidated City and County," regarding petty cash funds, hereby is amended by the addition of a NEW Division 8 to read as follows:

DIVISION 8. MARION COUNTY TREASURER'S OFFICE PETTY CASH FUNDS

Sec. 135-881. Created.

Pursuant to IC 36-1-8-3, the city-county council, as the fiscal body for the Consolidated City of Indianapolis and Marion County, Indiana, hereby establishes a petty cash fund in the amount of five hundred dollars (\$500.00) to be placed in the custody of the Marion County Treasurer (county treasurer) or their designee. The petty cash fund shall be used by the county treasurer's office to pay small or emergency items of operating expenses, such as postage, recording and filing fees, and related administrative uses.

Sec. 135-882. Administration.

The five-hundred dollars (\$500.00) for the treasurer's petty cash fund established under section 135-881 shall be paid by a warrant drawn on the appropriate fund in favor of the Treasurer without the need for an appropriation. The Treasurer shall account for the fund in the same manner as other funds and shall return the entire fund to the appropriate fund whenever there is a change in the custodian or when the fund is no longer needed.

SECTION 2. The expressed or implied repeal or amendment by this ordinance of any other ordinance or part of any other ordinance does not affect any rights or liabilities accrued, penalties incurred, or proceedings begun prior to the effective date of this ordinance. Those rights, liabilities, and proceedings are continued, and penalties shall be imposed and enforced under the repealed or amended ordinance as if this ordinance had not been adopted.

SECTION 3. Should any provision (section, paragraph, sentence, clause, or any other portion) of this ordinance be declared by a court of competent jurisdiction to be invalid for any reason, the remaining provision or provisions shall not be affected,

if and only if such remaining provisions can, without the invalid provision or provisions, be given the effect intended by the Council in adopting this ordinance. To this end the provisions of this ordinance are severable.

SECTION 4. This ordinance shall be in effect from and after its passage by the Council and compliance with Ind. Code § 36-3-4-14.

CITY-COUNTY GENERAL RESOLUTION NO. 9, 2025

A GENERAL RESOLUTION designating a portion of 25th Street from North Hillside Avenue to North Dr. Andrew J. Brown Avenue, as Pastor Frank Alexander Memorial Way.

WHEREAS, Pastor Frank Alexander was born June 21, 1943, to Elijah and Annie Alexander and was educated at Bishop College in Dallas, Texas and at The Southern Baptist Theological Seminary in Louisville, Kentucky; and

WHEREAS, Pastor Alexander served as an instructor/counselor for Indiana's Job Corps, as the director of Gateway Christian Center in Muncie, Indiana, as the director of Edna Martin Christian Center, and for 40 years he was the senior Pastor of Oasis of Hope Baptist Church, a place to serve and be served; and

WHEREAS, under Pastor Alexander's leadership College Avenue Baptist Church was one of the first Black churches in Indianapolis to out-grow its then-current facility and build a new facility named Oasis of Hope Baptist Church; and

WHEREAS, Pastor Alexander led his church in creating two community development corporations, purchasing a 185-unit apartment complex, building a 70-unit apartment complex for seniors and providing social services including youth employment training, after-school care, and summer day camps; and

WHEREAS, many community and state organizations have benefited from Pastor Alexander's expertise and faithfulness including Martindale/Brightwood Weed and Seed, Martindale/Brightwood Community Resurrection Partnership, Jobs Partnership of Greater Indianapolis, Indiana Healthy Marriage and Family Coalition, and Teacher Training for the Indiana Baptist State Convention; and

WHEREAS, Alexander's reach extended outside of Indianapolis with Oasis Mission for Orphans, Disabled and Unaccompanied Children (MODUC), a nonprofit started by Alexander in 1999 to support orphaned children after the Liberian Civil War in which he partnered with Thomas and Mary Beh, who turned their home into an orphanage after the conflict. This mission gave children access to education and medical care; and

WHEREAS, because of the profound affect he had on so many in this community, the city of Indianapolis proclaimed November 28, 2015, as Pastor Frank Alexander Day; now, therefore:

BE IT RESOLVED BY THE CITY-COUNTY COUNCIL OF THE CITY OF INDIANAPOLIS AND MARION COUNTY, INDIANA:

SECTION 1. The Indianapolis City-County Council does hereby honor the memory of Pastor Frank Alexander by designating that portion of 25th Street from Hillside Avenue to Dr. Andrew J. Brown Avenue, as Pastor Frank Alexander Memorial Way.

SECTION 2. As per Revised Code Section 431-405(a) this authorization shall expire fifteen (15) years after it is passed by the City-County Council.

SECTION 3. This resolution shall be in full force and effect upon adoption and compliance with IC 36-3-4-14.
