## HOUSE ENROLLED ACT No. 1208

AN ACT to amend the Indiana Code concerning local government.

Be it enacted by the General Assembly of the State of Indiana:

SECTION 1. IC 5-11-14.5 IS ADDED TO THE INDIANA CODE AS A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2025]:

Chapter 14.5. Training for Sheriffs and Designated Personnel for Oversight of Jail Commissary Funds

- Sec. 1. As used in this chapter, "fund" refers to a jail commissary fund established by IC 36-8-10-21.
- Sec. 2. As used in this chapter, "sheriff's designee" refers to a sheriff's designee, if applicable, who is responsible for the oversight or administration of a fund.
- Sec. 3. (a) The state board of accounts shall establish training requirements for a county sheriff and the sheriff's designee pertaining to the following:
  - (1) The proper use of forms prescribed by the state board of accounts.
  - (2) The keeping of the records for the fund.
  - (3) Best practices for financial management of the fund.
- (b) The state board of accounts may require the training requirements to be completed annually or biennially. The training may be fulfilled by:
  - (1) in-person training seminars;
  - (2) Internet based seminars;

- (3) participation through video conferences; or
- (4) other appropriate methods.

SECTION 2. IC 36-8-10-21, AS AMENDED BY P.L.216-2007, SECTION 55, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2025]: Sec. 21. (a) This section applies to any county that has a jail commissary that sells merchandise to immates.

- (b) A jail commissary fund is established, referred to in this section as "the fund". The fund is separate from the general fund, and money in the fund does not revert to the general fund.
- (c) The sheriff, or the sheriff's designee, shall deposit all money from commissary sales into the fund, which the sheriff or the sheriff's designee shall keep in a depository designated under IC 5-13-8.
- (d) The sheriff, or the sheriff's designee, at the sheriff's or the sheriff's designee's discretion and without appropriation by the county fiscal body, may disburse money from the fund for:
  - (1) merchandise for resale to inmates through the commissary;
  - (2) expenses of operating the commissary, including, but not limited to, facilities and personnel;
  - (3) special training in law enforcement for employees of the sheriff's department;
  - (4) equipment installed in the county jail;
  - (5) equipment, including vehicles and computers, computer software, communication devices, office machinery and furnishings, cameras and photographic equipment, animals, animal training, holding and feeding equipment and supplies, or attire used by an employee of the sheriff's department in the course of the employee's official duties;
  - (6) an activity provided to maintain order and discipline among the inmates of the county jail;
  - (7) an activity or program of the sheriff's department intended to reduce or prevent occurrences of criminal activity, including the following:
    - (A) Substance abuse.
    - (B) Child abuse.
    - (C) Domestic violence.
    - (D) Drinking and driving.
    - (E) Juvenile delinquency;
  - (8) expenses related to the establishment, operation, or maintenance of the sex and violent offender registry web site website under IC 36-2-13-5.5; or
  - (9) an audit or review of the fund by an independent certified public accountant for years the fund is not included in an



### audit under IC 5-11-1-24.4 or IC 5-11-1-25; or

(9) (10) any other purpose that benefits the sheriff's department that is mutually agreed upon by the county fiscal body and the county sheriff.

Money disbursed from the fund under this subsection must be supplemental or in addition to, rather than a replacement for, regular appropriations made to carry out the purposes listed in subdivisions (1) through (8).

- (e) The sheriff shall maintain a record of the fund's receipts and disbursements. The state board of accounts shall prescribe the form for this record. The sheriff shall semiannually provide a copy of this record of receipts and disbursements to the county fiscal body The semiannual reports are due on July + and December 31 of each year. not later than the following dates:
  - (1) January 15, for the quarter ending December 31 of the preceding year.
  - (2) April 15, for the quarter ending March 31 of a year.
  - (3) July 15, for the quarter ending June 30 of a year.
  - (4) October 15, for the quarter ending September 30 of a year.

#### CITY-COUNTY GENERAL RESOLUTION NO. 4, 2025 Proposal No. 392, 2024

PROPOSAL FOR A GENERAL RESOLUTION authorizing the payment of legal fees and litigation costs by the Marion County Sheriff's Office ("MCSO") from the Jail Commissary Fund.

WHEREAS, in 1972 the inmates of the Marion County Jail sued the Sheriff of Marion County in federal court for the unconstitutional conditions of the Marion County Jail, Cause IP-72-04246-C-B/S, U.S. District Court, Southern District of Indiana, Indianapolis Division; and

WHEREAS, when Frank J. Anderson was elected Sheriff in 2002 he made a commitment to the citizens of Marion County to resolve all pending litigation over unconstitutional conditions within the Marion County Jail by fully addressing and remedying those underlying conditions; and

WHEREAS, upon taking office on January 1, 2003, Sheriff Anderson discovered numerous other lawsuits by individual inmates, filed under 42 U.S. Code §1983, alleging deprivation of federal civil rights because of the Jail's unconstitutional conditions; and

WHEREAS, Sheriff Anderson promptly appointed a new Legal Deputy and a new law firm to address the many lawsuits facing the MCSO, and also requested that the City-County Council adopt a Resolution authorizing payment of the Sheriff's Office legal fees and litigation costs using the Jail Commissary Fund; and

WHEREAS, IC 36-8-10-21(d)(9) authorizes expenditures from the commissary fund for any "purpose that benefits the sheriff's department that is mutually agreed upon by the county fiscal body and the county sheriff'; and

WHEREAS, the legal expenses incurred in are a purpose for which expenditures are authorized from the jail commissary fund; and

WHEREAS, as is required by IC 36-8-10-21(d), the expenditure of such funds are supplemental or in addition to, rather than a replacement for, regular appropriations previously made; and

WHEREAS, Special Resolution No. 77, 2003, (Proposal 567, 2003), was adopted on October 27, 2003, and since that time MCSO legal fees and litigation costs have been borne by the Commissary Fund, rather than by the Sheriff's Office regular appropriation; and

WHEREAS, since 2003, the MCSO has semi-annually provided a copy of the Commissary Fund reports to the City-County Council detailing the legal fees and litigation costs incurred by the MCSO; and

WHEREAS, the FCC issued a ruling in July 2024 that will severely limit funds to be deposited within the Sheriff's Office Commissary Fund, and thereby reduce the MCSO's ability to fund legal fees and litigation expenses outside its regular appropriation; and

WHEREAS, the City-County Council approves continued funding of the MCSO legal fees and litigation costs from the Commissary Fund, and recognizes that in the future such legal fees and litigation expenses may need to be a part of the Sheriff's Office regular appropriation; now, therefore:

# BE IT RESOLVED BY THE CITY-COUNTY COUNCIL OF THE CITY OF INDIANAPOLIS AND OF MARION COUNTY, INDIANA:

SECTION 1. The City-County Council, pursuant to I.C. 36-8-10-21, hereby agrees to the expenditure of funds from the Jail Commissary Fund to pay the legal fees and litigation expenses incurred by the Marion County Sheriff.

SECTION 2. The Marion County Sheriff shall maintain a record of the Commissary Fund's receipts and disbursements and shall semi-annually continue to provide a copy of the record of receipts and disbursements to the City County Council, as required by I.C. 36-8-10-10-21(e).

SECTION 3. This resolution shall be in full force and effect upon adoption and compliance with IC §36-3-4-14.

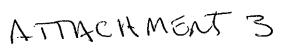
