There will be a meeting of the Metropolitan and Economic Development Committee of the City-County Council on **Monday, November 17, 2025**, beginning at **5:30 p.m.** in the **Public Assembly Room** of the City-County Building. It is anticipated that the following items may be considered by the Committee:

**PROPOSAL NO. 309, 2025** - reappoints David Baker to the Indianapolis Historic Preservation Commission

**PROPOSAL NO. 311, 2025** - reappoints Cathi Gould to the Marion County Property Tax Assessment Board of Appeals

**PROPOSAL NO. 313** - reappoints Kate Warpool to the Board of Business and Neighborhood Services

**PROPOSAL NO. 332, 2025** - accepts the Marion County Recorder's sworn statement and approves the Recorder's request to use money in the Perpetuation Fund to pay for other office expenses, including a special Property Fraud Alert and Veterans Honors promotion, including non-political billboards, radio and TV ads, and special event, during the 2026 fiscal year

**PROPOSAL NO. 333, 2025** - approves the 2026 Budget of the Downtown Economic Enhancement District, in the amount of \$5,500,000; pursuant to IC 36-7-40-7(a) and Sec. 121-1105 of the Revised Code

**PROPOSAL NO. 334, 2025** - amends various sections of the Code to reflect unsafe building and permitting process changes within the Department of Business and Neighborhood Services, in accordance with the state legislature

**PROPOSAL NO. 335, 2025** - approves a Payment in Lieu of Taxes (PILOT), as provided by IC 36-3-2-12, for an affordable housing project being financed in part with low-income housing tax credits, known as Capitol Station Apartments, consisting of 50 age-restricted affordable housing units, located at 7826 and 7828 Madison Avenue (District 23)

**PROPOSAL NO. 336, 2025** - approves a Payment in Lieu of Taxes (PILOT), as provided by IC 36-3-2-12, for an affordable housing project being financed in part with low-income housing tax credits, known as Promenade at the Square, consisting of 144 affordable housing units, located at 3919 Lafayette Road (District 5)

**PROPOSAL NO. 337, 2025** - approves a Payment in Lieu of Taxes (PILOT), as provided by IC 36-3-2-12, for an affordable housing project being financed in part with low-income housing tax credits, known as Walnut Ridge Apartments, consisting of 78 age-restricted affordable housing units, located at 3347 North Emerson Avenue (District 9)
